





Re: Revocation of Class 2 Water Supply and Class 1 Wastewater Certificates

Dear Mr. Taylor:

I am writing with regard to your violation of Ohio's Operator Certification regulations. On February 27, 2012, you pled no contest to one count of failing to comply with Ohio Revised Code (ORC) § 6111.07(A). In your plea agreement you agreed to relinquish you Class 2 Water Supply certificate WS2-1016237-66 and your Class 1 Wastewater Treatment Certificate WW1-1016237-62.

Pursuant to OAC Rule 3745-7-12 and ORC Chapters 6109 and 6111, your Class 2 Water Supply certificate WS2-1016237-66 and Class 1 Wastewater Treatment Certificate WW1-1016237-62 are hereby revoked. This final action was previously issued to you as a proposed action via certified mail on May 1, 2012, and a request for adjudication was not received by Ohio EPA.

You are hereby notified that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission pursuant to ORC § 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00, made payable to "Ohio Treasurer Josh Mandel," which the Commission, in its discretion, may reduce if by affidavit you demonstrate that payment of the full amount of the fee would cause extreme hardship. Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be


