**Public Notice
Proposed Rulemaking Governing
Scrap Tire Rules**

Notice is hereby given that the Director of Environmental Protection, under the authority of Sections 3734.02, 3734.70, 3734.71 and 3734.73 of the Ohio Revised Code and in accordance with Chapter 106, proposes to amend the following rules of the Ohio Administrative Code:

- 3745-27-54 Registration requirement for scrap tire transporters - annual registration certificate.
- 3745-27-62 Criteria for approval of application for a registration certificate or for a permit to install for a scrap tire facility.

These rules address scrap tire regulations.

The purpose of this rule making is to correct inaccurate statutory references and to make minor stylistic revisions in order to make the rules compliant with the Legislative Service Commission's (LSC) standards.

The public comment period will run until December 19, 2014. A public hearing on this proposed rule making will be held to consider public comments in accordance with Section 106.03 of the Ohio Revised Code. This hearing will be held on December 19, 2014 at 10:30 at Ohio EPA, Lazarus Government Center, 50 W. Town Street, Suite 700, Columbus, Ohio.

To facilitate the scheduling of oral presentations, persons intending to give testimony at the hearing should notify the Ohio EPA Public Interest Center, P.O. Box 1049, Columbus, Ohio 43216-1049, (614) 644-2160. Prior registration will ensure that registrants are heard ahead of those individuals who register at the hearing. Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rule making.

Written testimony should be sent to the attention of Michelle Braun at the Division of Materials and Waste Management, P.O. Box 1049, Columbus Ohio 43216-1049. Written comments may also be submitted to the Hearing Officer at the public hearing. Written testimony will receive the same consideration as oral testimony. All testimony received at the hearing or by close of business on December 19, 2014 will be considered by Ohio EPA prior to final action on this rulemaking proposal. Written comments submitted after this date may be considered as time and circumstances permit.
