Dear Mr. McCabe:

On June 30, 2010, Ohio EPA received Environmental Enterprises, Inc.'s request for the replacement of a 6,000 gallon horizontal steel hazardous waste storage tank with a 6,500 gallon vertical LHDPE tank. This results in a facility tank storage capacity increase of less than 25%. For this modification, Environmental Enterprises, Inc. submitted a Class 2 permit modification application¹. The Agency did not receive any verbal or written comments concerning the Class 2 modification. I have enclosed the final modified Ohio hazardous waste facility installation and operation permit (Permit) action that was issued by the director today. Please note that the modified Permit remains in effect until it is renewed, withdrawn, suspended or revoked.

You are hereby notified that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission pursuant to Section 3745.04 of the Ohio Revised Code. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00 which the Commission, in its discretion, may reduce if by affidavit you demonstrate that payment of the full amount of the fee would cause extreme hardship. Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section. An appeal may be filed with the Environmental Review Appeals Commission at the following address:

OHIO EPA ISSUES CLASS 2 MODIFIED HAZARDOUS WASTE PERMIT

On November 1, 2010, Ohio EPA issued a modified Hazardous Waste Facility Installation and Operation Permit (Permit) to Environmental Enterprises, Inc. for its facility at 4650 Spring Grove Avenue, Cincinnati, Ohio 45232. The EPA Identification Number for this facility is OHD083377010.

Why is Environmental Enterprises, Inc. modifying its Permit?

Environmental Enterprises, Inc. (EEI) is a permitted hazardous waste storage and treatment facility. All waste that comes into the facility is either treated or repackaged and sent off-site to a final disposal or recycling destination. EEI is requesting the replacement of a 6,000 gallon horizontal steel hazardous waste storage tank with a 6,500 gallon vertical LHDPE tank. This results in a facility tank storage capacity increase of less than 25%. This final modified permit will allow EEI to make the requested changes. To issue this final modified Permit, Ohio EPA determined that the modification application is complete and meets appropriate standards.

Can I appeal this final modified Permit?

Yes, if you are an officer of an agency of the state or of a political subdivision, acting in a representative capacity, or any person who would be aggrieved or adversely affected by this modified Permit, you have the right to appeal this Permit decision to the Environmental Review Appeals Commission (ERAC).

If I decide to appeal this final modified Permit, how and when must I make the appeal?

If you file an appeal, you must put it in writing no later than **December 1, 2010**. Your appeal must explain why you are appealing the action and the grounds you are using for your appeal. The appeal must be accompanied by a filing fee of \$70.00 which the Commission, in its discretion, may reduce if by affidavit you demonstrate that payment of the full amount of the fee would cause extreme hardship. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section. You must file your appeal, according to Ohio Revised Code § 3745.04 with ERAC at the following address: ***Environmental Review Appeals Commission***, 309 South Fourth Street, Room 222, Columbus, Ohio 43215. You must send a copy of the appeal to the director of Ohio EPA at the following address no later than three (3) days after you file it with ERAC: ***Chris Korleski, Director of Ohio EPA***, P.O. 

The Ohio Hazardous Waste Facility Installation and Operation Permit with the above-referenced permit number as issued by the Ohio Environmental Protection Agency and journalized on September 30, 2009, is hereby incorporated by reference in its entirety, except as it may be modified herein.

This modification of the permit shall remain in effect until such time as the Ohio Hazardous Waste Facility Installation and Operation Permit is renewed, modified, withdrawn, suspended or revoked.

The Permittee shall comply with all requirements of the modified Part B permit application as amended or supplemented on June 30, 2010 and September 15, 2010. The information contained in the modified Part B permit application is incorporated herein by reference. SUMMARY OF MODIFICATIONS TO HAZARDOUS WASTE
INSTALLATION AND OPERATION PERMIT

Modification of the Hazardous Waste Facility Installation and Operation Permit will authorize Environmental Enterprises, Inc. to make the following change:

Class 2 Modification:

Replace 6,000 gallon horizontal steel hazardous waste storage tank with a 6,500 gallon vertical LHDPE tank. This results in a facility tank storage capacity increase of less than 25%.

MODULE D - TANK STORAGE, TREATMENT, AND MANAGEMENT

D. MODULE HIGHLIGHTS

The facility's above ground storage tanks consist of four separate units, designated as numbers 1, 2, 3, and 4. All four tanks are located at the main building. Three of the tanks (Tank #1, 2, and 4) are located inside the main building and dedicated for conducting hazardous waste treatment activities. Tank #3 is located outside the main building within a concrete paved secondary containment system and is dedicated for conducting hazardous waste storage activities. Tanks #1 and 2 share a common secondary containment system while a bermed area surrounding the outside pad serves as secondary containment for Tank #3. Tank #4 secondary containment consists of the interior reactor area. The 4 hazardous waste tanks permitted at the facility are summarized in this Module and further described in Sections B and D of the application. Specific information on the locations of each of the permitted tanks are described in Section D.2 of the Application and shown on Figure B-6.

D.1. Tank Storage Quantity Limitation/Waste Identification

- (a) The Permittee may store a total volume of 6,500 gallons of hazardous waste in 1 tank, subject to the terms of this permit and information supplied within the application as summarized in the table below.

The Permittee shall store in tanks only the hazardous waste codes specified in Section A of the permit application.
