Revision to Explosive Gas Monitoring Plan**


Dear Commissioners:

On December 3, 2001, Ohio EPA received a request to revise the Explosive Gas Monitoring Plan for the Old Gallia County Landfill (ID#27-00-02). This submittal requested to abandon destroyed gas probes and to supplement the existing system with new temporary gas monitoring locations (punch bar locations). This alteration was required by Ohio Administrative Code 3745-27-12 (N), since a new occupied structure (a house) was constructed within 1000 feet of the landfill.

Ohio EPA has reviewed the Commissioners' request to revise the approved plan. This revision is in substantial compliance with OAC Rule 3745-27-12, and is hereby approved.

Issuance of this approval does not constitute expressed or implied agreement that the monitoring of the facility, if performed and implemented in accordance with the approved explosive gas monitoring plan and/or its terms and conditions, will constitute compliance with all applicable state and federal laws, rules and regulations.

You are hereby notified that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be made in writing and set forth the action complained of and the ground upon which the appeal is based. It must be filed with the commission within 30 days after notice of the director's action. A copy of the appeal must be served on the director within three days of filing with the commission. An appeal may be filed with the commission at the following address:


