**Re: Bigfoot Run Sanitary Landfill, Warren County
Ohio Administrative Code (OAC) Rule 3745-27-09(C) Approval**

Dear Ms. Dall:

On October 19, 2004, the Ohio Environmental Protection Agency (Ohio EPA), Division of Solid and Infectious Waste Management (DSWM), Southwest District Office (SWDO) received a request to store your Operating Record for the Bigfoot Run Landfill (Facility) at an alternate location to the Facility. Specifically, you asked that you be authorized to relocate the Operating Record to your offices at CECOS located at 5092 Aber Road, Williamsburg, Ohio 45176.

OAC Rule 3745-27-09(C) states, in part, that the operating record must be located at the sanitary landfill facility to be available for inspection by Ohio EPA and the approved health department during normal business hours. However, the director may approve an alternative location for the operating record upon the commencement of the post-closure care period.

Pursuant to OAC Rule 3745-27-09(C), you are hereby authorized to locate the Operating Record at the above listed address. The Operating Record shall be available to Ohio EPA and the Warren County Combined Health District or its designee during regular business hours.

You are hereby notified that this action of the Director of the Ohio EPA is final and may be appealed to the Environmental Review Appeals Commission (Commission) pursuant to Section 3745.04 of the Ohio Revised Code. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. It must be filed

with the Commission within thirty (30) days after notice of the Director's action. A copy of the appeal must be served on the Director within three (3) days of filing with the Commission. An appeal may be filed with the Commission at the following address:
